### ICGB 2018 NEWS SHEET 7: INTERNATIONAL TREASURER

#### NOMINATION CRITERIA & NOMINATION FORM

A new International Treasurer is due to be elected at the International Conference of Girls' Brigade 2018. The role of the Treasurer is documented in the 2010 International Rules and Procedures, along with eligibility criteria for any nominee.

#### Remit of the International Treasurer

In brief, the remit of the International Treasurer is described in our documentation as follows:-

*The Treasurer shall be appointed by the President's Committee and shall be a resident of the area covered by the Girls' Brigade International Fellowship in which the Registered Office of the Charity is situated (Currently Europe)*

The Treasurer shall:

- ensure that proper records are maintained of all financial transactions of GBIC
- present the examined/audited annual financial report at the Annual President's Committee meeting and General Meetings of GBIC
- manage the funds of GBIC according to the statutory requirements of the country in which GBIC is registered
- advise GBIC on financial matters
- prepare the annual budget for presentation at the Annual President's Committee meeting and General Meetings of GBIC
- seek approval of the President's Committee for all financial decisions made and ensure they are in compliance with the statutory requirements of the country where GBIC is registered.

#### Procedure for Nomination

All Member Countries are entitled to make a nomination, using the following procedure:-

1. Seek the nominee's acceptance of nomination.
2. Obtain completed CV form (attached) from the nominee
3. Complete the nomination form (below) and return to [home@gbworldwide.org](mailto:home@gbworldwide.org) by **28th February 2018**
4. The nominations will be circulated to members of the IPC for their decision prior to ICGB 2018
5. The IPC will announce the appointment of the International Treasurer (2018-2022) at the International Conference **July 2018**
